FILMING/PHOTOGRAPHY CONSENT FORM

- 1. St Austell AOS will ensure parents/guardians receive the Filming/Photography Consent Form which grants the permission for the filming or photographing of their child/children involved in the St Austell AOS production.
2. St Austell AOS agrees never to pass on addresses of their members. Should a point of contact be required, permission will be sought to exchange an email address only.
3. Any filming or professional photographs arranged by St Austell AOS will only be taken by an authorised person to do so.
4. If a parent/guardian has any concerns regarding what they consider to be intrusive or inappropriate videos or photographs, please report the matter in confidence to the Child Protection Officer for St Austell AOS.
